Pro Bono Spotlight

Clearing the bankruptcy backlog

Halloween is drawing near and Volunteer Legal Services Project has received a real treat.

Lucien A. Morin II, a partner at McConville Considine Cooman & Morin PC, has committed to taking four VLSP bankruptcy case referrals at a time until the current 22-case backlog is cleared.

Given the current economy, Morin's commitment is extraordinary. The 10 cases he already accepted constitute more than \$15,000 in donated legal services. Morin recently explained the factors that lead to his decision.

"I was brought up to give back to the community," he said. "VLSP serves a population that needs assistance. Third, [Former Chief Judge Judith S. Kaye] said lawyers are expected to do *pro bono*."

Morin also said he believes more could be done by members of the bankruptcy bar to assist low-income clients in our community.

"Bankruptcy practitioners have a responsibility to help. If every member of the bankruptcy bar took one VLSP case per year, there would be no backlog," said Morin, who concentrates his practice in the areas of bankruptcy, commercial law and real estate.

As a long-time VLSP volunteer, Morin he has observed a recent demographic change in clients.

"The middle class is creeping down. People who would not have been eligible for VLSP's services before the recession are eligible now, often due to job loss."

Single mothers and grandmothers raising grandchildren comprise the majority of VLSP's bankruptcy clients.

"When their wages get garnished, many workers in the health care and educational industries find that they are not able to put food on the table for their kids and pay rent."

As a volunteer, Morin also has helped veterans and senior citizens.

"Sometimes there are unintended consequences to grandma's generosity if she co-signs for a grandchild's loan and then the grandchild defaults," he said.

Regardless of their particular situations, Morin's VLSP clients have something in common: "They have not only the need but the desire to put their financial house in order. They don't want to repeat the process in eight years."

In addition to his dedicated service as a volunteer, Morin is a member of VLSP's Bankruptcy Advisory Committee, which is considering expanding its Debt Collection Advice Clinic to include a *pro se* bankruptcy clinic.

"We are looking to see if there are any alternatives that can assist with reducing the case backlog and help people move through the process faster," Morin said.

Pro bono assistance from bankruptcy attorneys still will be required if a *pro se* clinic is implemented. Clients will continue to require guidance on dischargability issues, for instance, he said.

"VLSP staff members have a genuine sense of wanting to help volunteers get the job done. The intake process is extremely thorough, which reduces the amount of time needed to complete the case."

Morin has offered to mentor attorneys who are new to bankruptcy practice.

For those uncertain about accepting a referral, Morin suggests volunteering to deliver the Power Point presentation constituting the first part of VLSP's Debt Collection Advice Clinic. Morin will be educating VLSP clients about the bankruptcy process on Nov. 3.

Regardless as to which *pro bono* opportunity is chosen, volunteering offers its own rewards.


"Doing *pro bono* makes you feel good. As a firm, when we do *pro bono*, it shows our clients and colleagues that we care about our community," Morin said.

Seasoned volunteers like Morin and those new to pro bono all can join VLSP, the MCBA and *Pro Bono* NY for *Pro Bono* Idol (with apologies to "American Idol"), a fun twist on a traditional *pro bono* fair being held in conjunction with the American Bar Association's week-long National Celebration of *Pro Bono*.
